# **CASE RESULTS:** Maternal & Paternal Families **Collide Over Guardianship**



Why it's important to make sure your Last Will and Testament, Trusts, and other estate planning documents are up to date, especially if you have minor children...

#### Consider the following case that we recently had to litigate:

Divorced parents had an eight year old son. The Mother and Father were the joint managing conservators of the child. The child lived with the Father as a result of the Mother not being suited to take care of him. The child lived with his father and his father's family for 4 years.

The father dies unexpectedly in a car accident. He had no estate planning documents in place regarding who the guardian of the child should be in the event of his death. The mother picks up the child to live with her.

Within a year, the mother falls ill and passes away. She also had no estate planning documents in place regarding who the guardian of the child should be in the event of her death. This resulted in the maternal and paternal families going to Court so a Judge could decide who should be the child's guardian.

During the Court proceeding, the Judge considered the Texas Estates Code's statute that specifies who has priority to be a guardian over a minor child, looked at who is suitable to serve as guardian, and also looked at the Estates Code list that states who is disqualified from being appointed as guardian.

**Our result:** The Judge found our client not only had priority to be the guardian, but also found that she was suitable to be appointed. Thus, our client was appointed as the guardian of her nephew.

Although we were successful for our client, in the end the family relationship was strained.

If you do not have the proper documents in place, the statute provides the priority of who can be a guardian and also lists who would be disqualified from being the guardian. Therefore, it is important that you not only have your Last Will and Testament, Trusts, and Designation of Guardian signed, but it is also important that you review these documents frequently.

We represented the paternal aunt in the case.

The Reverchon Round Up was a great community event. We were able to plant trees, clear out trash, clean up the playground, and remove fallen branches.




