

### CAN FACEBOOK Ruin Your Case?

Popular social media sites can be a real headache if you're not careful.

With 1.11 billion users, Facebook is undoubtedly the most popular social media site in the world. You need to be careful what you post and share online especially if you are in the midst of a personal injury claim. It can actually ruin your case. How? Consider this:

- -Photos posted by your friends can be viewed by people outside your network of "friends" despite your privacy settings.
- -Courts have ordered injured plaintiffs to produce their Facebook pages to insurance company lawyers.
- -Evidence from Facebook has been admitted in courts and has been used by police, investigators and media.
- -Law clerks for insurance defense lawyers check Facebook for their opponents' pages, profiles and pictures.
- So what steps can you take to protect yourself?
  - \*Critically review the photos and posts on your social media sites and remove anything that you wouldn't want the insurance company lawyer to see.
  - \*Check your privacy settings and see if you can block certain people from being able to see that you are even on the site.
  - \*Search for your name in the search field and review the information that comes up to make sure it's acceptable. Do the same for sites like Google+ and YouTube.
  - \*Never accept friend requests or respond to messages through social media sites from people you do not know.
- While the above steps are not foolproof, they will make it less likely that your personal information ends up in the wrong hands.



## NIGHTTIME DRIVING + TEENS + CELL PHONES = **bad news**

Like any other drivers, teenagers face a variety of risks when they get behind the wheel – especially if they drink and drive, speed, or fail to use a seat belt.

But, surprisingly, the biggest risk factor for teenage drivers is driving after dark, according to a recent study conducted by the Texas Transportation Institute.

Researchers who studied traffic fatality rates found that despite an overall drop in traffic deaths, nighttime fatalities actually increased. A closer look at the numbers revealed that among drivers over the age of 20, alcohol was to blame for the proportional increase in deaths, but that wasn't the case for teen drivers. The fatal crash rate of 16-year-olds is nearly twice as high at night.

So, what accounted for the rise in teen nighttime traffic deaths? Researchers pointed to one other crucial factor – The huge surge in cell phone use by teenagers.

Today's teenagers, having grown up with cell phones, are often so comfortable with a cell phone in their hands that they can develop a false sense of security and figure they can easily text or talk on a cell phone while driving. In fact, 48% of teen respondents say they talk on a cell phone or text, at least sometimes, while driving. Unfortunately, that's a decision that leads to disastrous consequences.
